RULES:

- 1) This competition is organized under FIAP patronage in **Luxembourg**, which is the official seat of FIAP. Consequently, the participation and the awards of this special competition will be eligible for FIAP distinctions according to current FIAP regulations.
- 2) Participation in this competition is free of charge.
- 3) There will be a single digital section into which colour and/or black and white images may be entered.
- 4) The subject is : **“The world in 2020”**. Only photos taken during 2020 may be entered. This subject is strictly for **“Traditional”** photographs (TRAD) and must comply with the following FIAP definition: A **“traditional photograph”** maintains the original single capture image content with minimal adjustments which should not alter the reality of the scene and should appear natural. Rearranging, replacing, adding to or removing any part of the original image except by cropping is strictly forbidden. HDR (High Dynamic Range) and focus-stacking techniques, whether done in camera or post-capture, are strictly forbidden.
Photos previously entered in the FIAP “We Stay Home” competition will not be accepted.
- 5) Each photograph must have a unique title. Words such as **“Untitled”** are not acceptable even in part of the image title, nor are camera capture file names. Photos with watermarks will not be accepted.
- 6) Competition is open for entries: 1st September 2020. Entry closing date: 31st December 2020 (Central European Time).

- 7) The judging team will be composed of members of the FIAP Executive Board. The judging will be conducted according to FIAP DOC 018/2017 on 31st January 2021. Judging will be done remotely as per special decisions taken due to the COVID-19 situation around the world. An entry may be rejected if it does not comply with the rules and conditions of the competition. The decision of the judges will be final and cannot be appealed.
- 8) Announcement of the results: 15th February 2021. Each participant will receive an email report with the results of their photos. All results will be uploaded to the competition website.
- 9) A PDF catalogue will be available for download from the website. FIAP may also consider publishing a book to commemorate its anniversary. In this case, authors may be asked to send their files in higher resolution.
- 10) The participant who has achieved the highest number of acceptances in this competition will be proclaimed **“Best Author”**. In the event of a tie, attributed awards will be taken into consideration to choose the winner. The Best Author will be invited to the next FIAP Photo-meeting, where attendance, transport & hotel accommodation costs will be covered by FIAP (bookings will be arranged by FIAP in consultation with the winner).

With the sole act of submitting their images or files to a salon under FIAP Patronage, the participant accepts without exception and with no objection that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions

even if the entrant is not a member of FIAP; that FIAP will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP and that in case of sanctions following the non compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules.

COPYRIGHT - USE OF PHOTOGRAPHS - PERSONAL DATA:

All the participating photographs will be kept in the archives of FIAP. FIAP will have the right to use these photographs for promotional (non-commercial) purposes with the name of the photographer and the copyright will not be paid to the owner of the photograph (it could happen that in graphic collage works photo, the author's name cannot be added). Unless otherwise specified by the author, reproduction of the works and their use in a printed and / or digital album is authorized. Authors should have all necessary permissions for the people or places represented in their works. Any dispute arising from the use of photographs (on behalf of the Photographer) in print or electronic media (web, emails) in this manner will be the sole responsibility of the Entrant. By entering the contest, the authors or their parents or legal guardians of authors under the age of 18 certify that they have the consent or model release of each of the persons identifiable in their photos (and whether they are over the age of under 18, signed by their parent or guardian) whenever necessary and that they can provide copies of these upon request. The captured images must be entirely the work of the photographer. Use of images from any other source, including, but not limited to royalty-free stock images and clipart is not permitted. By submitting an application, the participant certifies that the work is his own (pseudonyms are not authorized) and authorizes FIAP to reproduce all or part of the material entered free of charge for publication and / or display in the media related to the Competition. This can include a low resolution post on a website. FIAP assumes no responsibility for any misuse of copyright. By entering the competition, authors or their parents or legal guardians of authors under the age of 18 explicitly agree that the personal data they

have provided, including email addresses, will be held, processed and used by the organizer for purposes associated with any FIAP activity. They also acknowledge and agree that participation in the competition means that photographs and listings with the names of the authors may be public and advertised on websites and social media sites such as Facebook. These rules and regulations come into effect after uploading photos of participants for this contest. It is considered that by participating in this contest, the participant has read and accepted all the rules. Entrants do not have the right to object to the rules after participating in this contest. By entering the competition, the authors or their parents or legal guardians of authors under the age of 18 declare and acknowledge that they take full and exclusive responsibility for the photos they have submitted and that they agree to indemnify, defend and release FIAP from all liability and all liability of third parties for any injury, loss, claim, action, demand or damage of any kind arising from or in connection with this competition, including, without limitation, any third party claim for violation copyright or a violation of an individual's right to defamation or the right to privacy and / or publicity.
